

## **Anaheim Ducks AHL Affiliate SEASON TICKET DEPOSIT TERMS AND CONDITIONS**

By submitting the deposit ("Deposit") in the amount set forth on the form accompanying these terms and conditions, you ("Holder") are agreeing to the following terms and conditions:

1. Season Tickets Priority. This is not an agreement to purchase or provide season tickets. Submitting the Deposit will provide Holder with the opportunity to receive an invitation to an Anaheim Ducks AHL Affiliate Club ("Club") Select-A-Seat event on a date to be announced and the opportunity to purchase season tickets (collectively, "Season Tickets" and individually, "Season Ticket") for the 2015-16 American Hockey League ("AHL") season ("Season") at the Valley View Casino Center (the "Arena"). Seat locations will be subject to availability and determined in accordance with rules and regulations established by Club. Season Tickets will be made available at prices and under other terms, including the deadline for such purchase and Season Ticket Terms and Conditions, as determined by the Club from time-to-time in its sole discretion. Any benefit associated with the Deposit, including, but not limited to, priority for selecting seat locations, discounts, the opportunity to participate in Select-A-Seat and the opportunity to purchase Season Tickets, may be withheld, modified and/or revoked by the Club at any time in its sole and absolute discretion. Failure to participate in Select-A-Seat as announced or to purchase Season Tickets shall be deemed, in the Club's discretion, forfeiture of the benefits as described above. The Club's receipt of the Deposit does not guarantee or imply, in any manner, that Season Tickets will be available for purchase in Holder's preferred seating location or pricing package. Holder may not assign or transfer in any manner the benefits or rights granted herein, including, priority or an invitation to Select-A-Seat.
2. Deposit. In the event Holder provides written notice (see paragraph 3 below) to the Club that Holder desires to cancel Holder's priority or does not participate in the Select-A-Seat, the Club will provide a refund to Holder in the same tender such Deposit was received within sixty (60) days after the Select-A-Seat event, or earlier in the Club's discretion. Any interest accruing on or with respect to the Deposit shall belong solely to the Club. In the event Holder agrees to purchase Season Tickets, the Deposit will be applied to the first installment of the fee applicable to such Season Tickets, in accordance with the applicable Season Tickets Terms and Conditions. These terms and conditions authorize the Club to charge the credit card provided by Holder at the time of submitting the Deposit.
3. Notices. Holder is obligated to promptly notify the Club of any change of address. Such notice must be in writing and shall include the signature of the Holder or authorized officer if Holder is a legal entity.
